CHEMICAL THREAT AGENTS: THE COMMUNITY PROVIDER'S PERSPECTIVE SATELLITE BROADCAST

Program Rebroadcasts

Place: Your local satellite site or via recording at location determined by your facility. Location for viewing a recording is at viewer discretion and as your facility's resources permit.

Purpose: To prepare healthcare providers to appropriately respond to and treat all populations and age groups regarding chemical warfare and terrorism. And, to prepare healthcare providers to answer the questions their patients may have related to family protective measures, how to shelter in place, and where to obtain resources to help answer these concerns.

This broadcast is a stand-alone educational activity and requires participant viewing only.

**Outcome
Objectives:**

At completion of this instruction, the participant should be able to:

1. briefly describe fundamentals of the four major chemical warfare agent classes;
2. compare and contrast the clinical features and management of sulfur mustard casualties, thermal burn casualties, and epidermal necrolysis casualties;

3. apply concepts of chemical warfare agent injury and medical management to population groups other than healthy males age 18-50; and
4. compose a brief for your patients and neighbors that will help them plan for, and respond to, a chemical agent incident in their own community.

Target Audience:

Medical care providers, emergency and intensive care workers, and rehabilitation medical care providers.

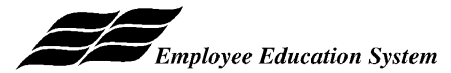
